<u>Position Summary</u>: The incumbent will administer the distribution of all water resources on the Spirit Lake Reservation. Supervises program employees and provides guidance and assistance to all program staff to ensure the timely construction and maintenance of the water system.

Major Duties:

- Develop a work plan and amendments to describe the scope, location and extent of the work activities.
- Responsible for the budget development, environmental quality, safety, property management, supply management and coordination and supervision of work activities.
- Provide performance and financial reports in accordance with the terms of the cooperative agreements for construction activities.
- Ensure the efficient operation and maintenance of the water treatment plant and also ensure that adequate operational and management records are maintained.
- Provide safe working conditions, safety equipment and proper tools for maximum efficiency and safety operation.
- Establish operator training programs in coordination with State and Federal programs.
- Develop and oversee the continuous preventative maintenance of water system facilities.
- Maintain updated knowledge of State and Federal Laws, Rules and Regulations of actions that affect Tribal Land Management of Water Resources.
- Maintain records of work accomplished and prepare reports for the Tribe and as required by the respective cooperative agreements.
- On call 24/7 to respond to emergency situations affecting the water system.
- Provide supervision of department staff.
- Other duties as assigned

Qualifications:

- Bachelors degree in the field of Civil Engineering preferred with knowledge in water quality control or Associates degree with related work experience.
- Applicant must possess excellent management and organizational skills.
- Knowledge of water quality control with knowledge of environmental laws and regulations.

- Must possess and maintain a current, active and unrestricted ND Driver's license through course of employment, insurable under SLT driving policy.
- Computer knowledge and proficiency required.
